

## Turquoise Trail Corridor Management Plan Version 2.0

- The first questionnaire was our original questionnaire designed to allow the public to fill it out in a short amount of time.
- Based on the comments from the first round of answers, the first questionnaire was revised to provide stakeholders with more choice in their answers.

Although the original questionnaire provided adequate space for answers, the spaces were taken out to save paper in this appendix.
